NFU Cymru Briefing – Responding to: NRW Consultation on its regulatory fees and charges 2023/24

NRW is consulting on their regulatory fees and charges. Feedback will be used to inform NRW's final charging scheme implemented from 1 April 2023, subject to Welsh Government approval.

NRW has undertaken a Strategic Review of Charging (SRoC). This has focussed on the changes to the fees and charges associated with applications for **new permits and amended permits** with some very large increases in fees proposed. NRW is proposing a 6% increase to its **annual subsistence charges.** The NFU Cymru Briefing summarising proposals can be <u>accessed here</u>. Ahead of the consultation closing date on **Friday 6 January 2023**, NFU Cymru, in addition to preparing our own consultation response, is encouraging members to provide feedback directly to NRW on proposals.

NRW is gathering feedback via an <u>online survey</u>. There are several sections in the <u>survey</u>, the main questions of relevance to farming are as follows:

Questions 1 to 5 are generic questions which have to be completed

• Proposals for new and amended permits

Installations (Standard Rules Permit for on-farm AD using farm waste only) Question 10 & 11

Environmental Permitting Regulations (Rearing of pigs and poultry) - Questions 12 & 13

Water Resources (Abstraction and Impoundment Licences) - Questions 27 & 28

• Proposals for annual subsistence charges (6%)

- Farmers will be dismayed at the scale of increases proposed more than tenfold in some instances
- We understand NRW has a duty to recover its costs but we are disappointed NRW has not made more effort to streamline the application process and deliver efficiencies to reduce costs
- Proposals are likely to have unintended consequences and work against important Welsh Government policy priorities such as sheep scab eradication or renewable energy generation
- Proposed increases in charges such as EPR (Intensive Pigs and Poultry) come at an already worrying time for the sector
- The proposed cost increases on this scale are a disincentive to improve management practices and place limitations on diversification options for farmers in Wales
- Proposals particularly disadvantage new entrants/young farmers.
