## New process from 5th January 2024

Make your dealership aware that you are an NFU member and are eligible for the discount. Dealership will complete relevant NFU member discount approval paperwork with you to email to the NFU for approval of the discount.

Terms and Conditions

- 1. This programme is available to NFU Farmer and Grower, NFU Partner, NFU Retired, NFU Countryside, NFU Associate, NFU Pro and NFU Corporate members only, which meet the following criteria:
  - Be an NFU Farmer and Grower member, Partner (provided they are linked to an F&G record), NFU Retired, i. NFU Countryside, NFU Associate, NFU Pro or NFU Corporate member.
    - Have maintained 14 months of continuous membership at point of request, and
  - ii. Have made a minimum of 14 months subscription payment with a Direct Debit instruction set up for the current iii. membership year if paying by Direct Debit or have made a minimum of 14 months subscription payment and in addition, have paid in full for the current membership year at the point of request, subject to NFU discretion, if a cash paver.
  - In addition, NFU Partner memberships must be linked to a valid NFU Farmer & Grower membership to be iv. eligible.
- 2. This programme is not available to any other NFU membership categories or any member that does not meet the eligibility criteria. as set out in Point 1.
- 3 Eligible members are allowed a maximum of 2 vehicle discounts per membership annum (For the avoidance of doubt, a year constitutes 1st November - 31st October). This applies across all NFU vehicle partners and is not per manufacturer. However, requests for additional volume will be considered on an exceptional basis.
- A member with associated businesses in selling motor vehicles is not applicable or entitled to receive vehicle discount 4. through the discount programme.
- The NFU discount is IN ADDITION to any support you negotiate directly with your Subaru dealer and will be deducted by 5. the supplying dealer from the basic price (before VAT, delivery and On The Road charges).
- The NFU discount applies to the basic retail price of the vehicle and does not apply to chargeable special paint, 6. accessories, parts or servicing.
- The NFU discount applies to retail sales in the UK mainland and Northern Ireland. 7.
- The NFU discount available on standard models only (limited editions and special editions excluded) and purchase is 8. subject to the availability of the vehicle type and model.
